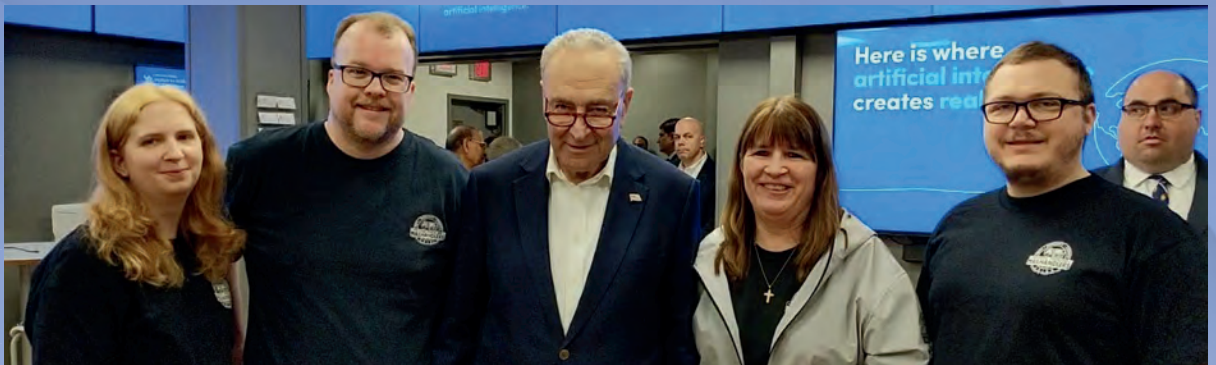


LOCAL 309

LOCAL 318 FL-2 DISTRICT ADVANCE STEWARDS TRAINING IN ORLANDO, FLORIDA

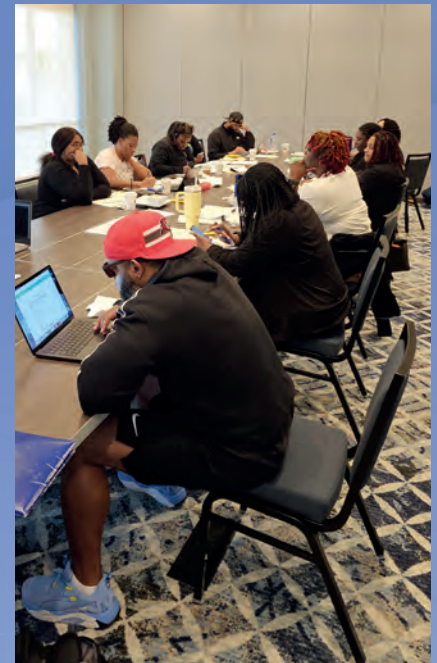
